

Job Title: Licensed Psychologist, Oregon Certified Forensic Evaluator

Location: Hybrid (mostly remote, must be located in Oregon)

Job Type: Part-time or full-time employee and contract positions

Licensed Psychologist Position Overview:

We are seeking forensically trained psychologists who are licensed (or license eligible) in Oregon. We are open to both early career and more seasoned psychologists who are dedicated, thoughtful professionals. We will provide consultation, training, and support at the level needed for each team member.

The ideal candidate will have a strong foundation in forensic psychological assessment. If you are an early career psychologist or newer to forensic work, this position offers a unique opportunity for professional growth and development under the mentorship of an experienced psychologist.

Although Nexus is based in Eugene, OR, we provide services throughout the state of Oregon. Our psychologists often travel to meet with clients either in correctional facilities or the offices of the attorneys we work with. Remote evaluations via secure videoconference are also frequently used.

This position can be either a W-2 employee or 1099-contract. Position type will depend on your unique situation and the level of support required.

Key Responsibilities:

- Conduct comprehensive forensic evaluations of adults involved with the criminal justice system.
- Administer, score, and interpret psychological tests and measures when needed.
- Produce detailed and timely evaluation reports in accordance with ethical and legal standards.
- Communicate effectively with attorneys, judges, colleagues, and clients.
- Testify in court as an expert witness
- Participate in team meetings, ongoing training opportunities, and in continuous professional development to stay current with advancements in the field.

Mandatory Qualifications:

- Doctoral degree (Ph.D. or Psy.D.) in psychology from an APA-accredited doctoral program.
- Completion of an APA-accredited internship.
- Active Oregon license or license-eligible
- Certification as a forensic evaluator in Oregon or certification eligible
- Strong foundation in psychological assessment, including cognitive, personality, and response style.
- Commitment to provision of culturally informed assessments including for those with diverse ethnic and linguistic backgrounds, gender identities, and sexual orientations.
- Excellent written and verbal communication skills.
- Strong diagnostic skills.
- Excellent attention to detail, strong organizational skills, and strong work ethic.
- Freedom from any criminal history.
- Ability to work collaboratively within and across disciplines.
- Commitment to ethical practice and ongoing professional development.
- Must be able to organize and manage time well and independently.

Preferred Qualifications:

- Experience working with a wide range of populations, most notably in a forensic capacity.
- Familiarity with the Microsoft Product Suite.

Benefits:

- Above market wages. Wage is hourly for W-2 employees or a percentage-split for 1099 contractors. Full-time W-2 employees have earning potential ranging from approximately \$175,000 to \$220,000 per year (with 4 weeks of time off) depending on level of experience.
